How is a Trust led?

The Trust is led by Ginny Rhodes, our CEO and is governed by Members, Trustees and Local Advisors.

An easy way to think about this role is setting the conditions for schools to thrive. Ginny is an experienced leader in education, she has been teaching for 30 years and a Headteacher for 10 of those.

In addition, Ginny is currently a Lead Ofsted Inspector and serves on the AQA Examination Board of Trustees. Alongside this work, Ginny is a governor at Wellington College where she plays a pivotal role in developing the state and independent school partnerships.



Members

Members have an “eyes on but hands off” role and ensure that the vision and values of the Trust are upheld. They assess if the Trustees are performing well, by ensuring that the purpose and charitable objectives are being fulfilled.

That said there are some critical decisions that sit with Members and even more so if a Trust is failing.



Trustees

Trustees on the other hand have a very significant hands-on legal responsibility and are the key decision makers.

Trustees are appointed using a skills matrix to ensure expertise across the fields of education; legal; business; H.R and finance.

The role of Trustee comes with specific legal responsibilities, which include:

- Ensuring the organisation remains solvent and spends money in accordance with its charitable objectives
- Ensuring the schools in the Trust provide a good standard of education

Local Advisors

Local Advisors act as the governance for their school. They play a pivotal role by holding the Headteacher to account.

The organisation of Governance for the Trust is set out in a document known as the Scheme of Delegation.

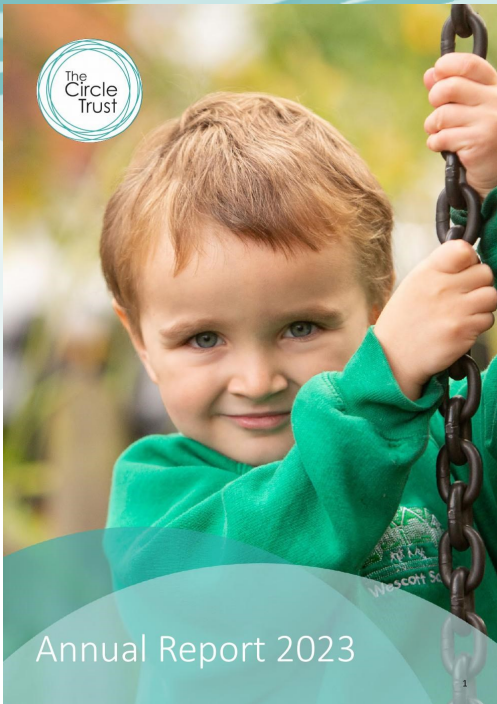
As a Trust we are responsible for the education of your child, employment of hundreds of staff and millions of pounds of public money, so it is important that governance is strong and accountable to all.
